WORK EQUIPMENT: REFERENCE ENTRY INTO FORCE FOR THE PERIODIC CHECKS.

Yet another delay for the entry into force of the Decree of 11 April 2011 relating to the discipline of how to conduct periodic audits.

The Official Gazette No. Dell'24 24 January 2012 was posted on the Inter-Ministerial Decree 20 January 2012 on the postponement of the entry into force of the Decree of 11 April 2011 that the move further 120 days. The decree of April 11, 2011 was to take effect within 90 days initially and then July 28, 2011, was subsequently postponed to January 24, 2012, and now with this further postponement will enter into force May 23, 2012. Concerning the content of the decree, which is in line with what has already happened before the checks to the elevators and electrical systems in which private entities operating within a scheme essentially public, as clarified by Confindustria note in the memo of July 13 2011.

The Commission and the persons entitled to carry out checks.

Is established, the Ministry of Labour, a commission (also composed by the Ministries of Economic Development and Health, INAIL and the Regions) with the "task, among other things, to establish and update the list of persons authorized to carry out the verification (Annex III of the Ministerial Decree). <omissis>

First test.

The employer takes the first of the periodic checks INAIL, "also indicating the name of the qualified entity, public or private - the list INAIL - of which it intends to use if the entity can not carry out the verification directly. <omissis>

Subsequent checks (periodic)

For periodic checks after the first, which is responsible for the ASL, the employer requires the testing, indicating, in this case, the name of the qualified entity, public or private (listed ASL) that it intends to use if the entity can not carry out the verification directly. <omissis>

How to make and require verification

And Annex II of the decree that lays down procedures to perform periodic checks.

The facilities are divided into the following groups:

- ¬ SC group: lifting of non-powered hand dryers and centrifugal force;
- ¬ SP group: People lifting equipment: for example bridges, working platforms, lifts, ...;
- ¬ GVR group (gas, steam, heating): this group includes pressure equipment and furnaces for chemical <omissis>
