MODIFICATIONS TO THE DECREE OF 81 MATERIAL SAFETY, HEALTH AND FIRE RISK ASSESSMENT DOCUMENT WITH THE DECREE LAW NO 69 OF 21 June 2013 (DECREE OF FARE) AND CONVERTED INTO LAW WITH THE LAW OF THE ORDINARY PARLIAMENT August 9, 2013 N. 98

3. - DUVRI STUDIES

1. Article .26, paragraph 3, of Legislative Decree no. N . 81/2008 allows MODIFIED (not impose) for certain types of contractors who carry out activities with a low occupational risk the possibility of replacing the drafting of DUVRI with the identification of a "just in charge, in possession of training, experience and professional competence, appropriate and specifications in connection with an assignment, as well as periodic updating and direct knowledge. " As said, the choice of the DUVRI and 's ' charge' refers only to cases in which the activity of the principal result of low risk to the safety and health of workers involved, but everything is on hold at a given as it will define a specific implementing decree . For the moment, not yet issued the decree application that identifies low -risk activities, it remains the obligation of preparing the DUVRI. The Commissioner to Supervise Cooperation and Coordination (ISCC, or Superintendent Cooperation and Coordination - SCC) between businesses in the awarding of works, services and supplies " will obviously have to be identified in writing by a certain date, and written acceptance of ' appointment (acceptance that must be a specific date). The whole thing can also be made with the computer systems of certified mail and digital signatures. It is also believed that the identification of the Distributor (ISCC or SCC) or its replacement must be given immediate evidence already in the contract or work . It should be added then that the identification of the above is not a mere formal activity, but gives essentially the powers and obligations that has the figure of the CSE . (Coordinator of the pipeline for execution of work), which is conceptually the same as the charge of a new figure referred to in Article 26 Legislative Decree no. N . 81/2008) .

2. DISCLAIMER obligation of DUVRI for service contracts of works and / or services and / or supplies of less than five men / day. It is innovated paragraph 3 bis of Decree - D . n . 81/2008, greatly expanding the ability to omit the preparation of IRAD , even if in fact " subject to the provisions of paragraphs 1 and 2" which still weigh and which must be fulfilled in writing. Ultimately, the Conversion Law n . 98/2013 of Decree no . 69 amends Article 26 of Legislative Decree . N . 81/2008 also paragraph 3a providing that the exemption applies to DUVRI jobs lasting less than 5 men / day , and then in the opposite case where it is a job, work or service entrusted to

businesses or self-employed , lasting more than five man-days , the DUVRI is always required , unless it is initiated by a client from work classified as low risk. In this case , the DUVRI can be replaced by the identification of a ' charge' , which can thus also oversee activities of significant importance to the duration and number of people involved , and even if lasting more than five men day.
